## Past Meeting Minutes from the 11/22/15 Annual Parish Meeting

## I. OPENING PRAYER:

Father Gregory led the opening prayer at 11:35AM

## II. PREVIOUS MEETING MINUTES:

The May 17, 2015 Semi-Annual Parish Meeting Minutes were reviewed. Shirley Dean made a motion to accept the minutes, Tina Parrish seconded. Motion carried.
III. RECTOR'S REPORT: Fr. Gregory Safchuk

Father indicated his report is in the annual packet, hopefully everyone has read it. The issues of concern were presented in the packet. If anyone has a question of the pastoral nature, Father stated he would now address them.
IV. PRESIDENT'S REPORT: Michael Thompson

Michael Thompson explained all his comments are also in the annual packet. Michael asked if anyone had questions from the floor. He thanked everyone for their hard work and generosity over the past year.
V. TREASURER'S REPORT: Matthew Nimmer

## YEAR-TO-DATE:

Matthew presented the highlights of his report, year to date first; profit/loss January through October 2015. We are on track to exceed last year by $3.5 \%$.

We have a gain of $\$ 53,000.00$ through October. $\$ 50,000.00$ of that sum is designated iconography.

## 2016 BUDGET:

Proposed budget income - Matthew has not increased the amounts for anticipated revenue. Matthew asked if anyone had any thoughts on that subject. Bazaar income line remains the same as well.

Expenses January through October 2015 were increased collectively by approximately $\$ 20,600.00$ from 2014. The primary contributions to that increase came from electrical usage, general facility maintenance and office operations.

Matthew asked if there were any questions or thoughts on the report? Shirley Dean noticed that we have not increased the flower budget in years; the cost of flowers has gone up so she proposed we increase the flower budget by $\$ 500.00$. Shirley motioned we amend the budget to $\$ 3,000.00$. Pat Ihnat seconded. Motion carried.

Michael Thompson asked if there was any other budget line items to be discussed? There were none.

Motion to accept the Budget as Amended was made by Mark Phinney, and seconded by Shirley Dean. Motion carried.

## VI. OLD BUSINESS:

## 1) ICONOGRAPHY UPDATE: Fr. Gregory Safchuk

We are just about to begin the completion of iconography phase 2. The iconographers are scheduled to arrive next weekend. Father recommended that they rent a car for their transportation needs. Date of completion is scheduled for Christmas Eve. The amount spent last year on iconography was approximately $\$ 60,000.00$. Our contract with Dimitri and company was $\$ 45,000.00$ for phase 1 . The additional funds spent were for scaffolding, lighting, T\&C Construction for their work on the circle. We will pay $\$ 60,100.00$ at the satisfactory completion of phase 2 . We have collected to date, $\$ 105,211.56$. This should cover contract cost and incidentals. Thank you very much for your generosity. Inscription we are proposing to have over the Icon of the Ascension (last beam above the altar) is "Heaven and Earth are full of thy Glory, Hosanna in the Highest". Father stated these words are very appropriate to our worship and gathering.

Paul Dean, President of Saint Mark Chapter of the Fellowship of Orthodox Christians in America, presented a check in the amount of $\$ 3,000.00$ which was realized through the fundraiser Chari-Tea. Father accepted the check on behalf of Karen Phinney, iconography committee chairperson.

Question was asked regarding the preparation of meals for the iconographers as previously done. A sign-up sheet will be supplied for donation times (speak with Matushka Sasha). In addition, monies will be given for meals to ease parishioner contribution and help with their dietary restrictions.

## 2) OTHER OLD BUSINESS- BAZAAR UPDATE: Tina Burpee

One change to the Agenda: Tina Burpee will speak regarding this year's bazaar and also plans for next year. Tina thanked everyone for their participation; she specified that this year was the first in 35 years that every line on the volunteer sheet was filled. On December $6^{\text {th }}$, we will have a post bazaar meeting, perhaps the teen room. The only negative comment was regarding closing time. The amount raised was approximately $\$ 31,000.00$, down from $\$ 36,000.00$ in 2014. Tina stated that one of our patrons commented "our parish had the most friendly people, talking and smiling". Tina was thanked for her leadership and was given a round of applause.

## VII. NEW BUSINESS:

## 1) ELECTION OF COUNCIL MEMBERS: George Freimann

We must elect four council members and re-election of our auditors. George Freimann presented the slate. John Bilyeu and Paulina Masick will fill the vacancies held by Chris German and Konstantin Lyubimov. Skip Mersereau and Debbie Sieff agree to remain on council. Michael Thompson asked for any nominations from the floor? Shirley Dean made a motion to accept the nomination as presented, motion seconded by Tammy Jacobsen. Motion carried.
2) ELECTION OF AUDITORS: George Freimann

Auditors- George Freimann stated that Lori Hottle and Jack Albert will remain as auditors. No nominations were made from the floor. Motion to accept the nomination as presented, made by Mark Phinney, seconded by Tammy Jacobsen. Motion carried.
3) AUDITORS REPORT 2013 \& 2014: Jack Albert and Lori Hottle

The report covers calendar year ending December 31, 2014. Jack shared procedure; basically you do not check every entry on the books you do it on an analytical basis and so forth to determine if the financial statement which you see for December 31, 2014 are free of any mistakes. They uncovered one entry which was suggested to the treasurer, Michael Hydock. The entry was sanctuary iconography, in the amount of \$60,000.00 should be capitalized on the balance sheet as an asset. Lori Hottle explained that they adjusted financials for 2014. They went back and made the entry retroactive so that 2014 has been adjusted. The adjusted financials are available for your review. Jack stated that this (2014) was Michael Hydock's last year as treasurer; he did a great job maintaining the records; many thanks to Michael.

Jack asked if there were any questions from the floor, there were none. The auditors were given a round of applause.

## 4) REVISION OF PARISH BYLAWS:

Lastly, the revision of Parish Bylaws. Dimitri Datch and Don Truitt are working on this. We must transition our bylaws into the language of the OCA bylaws. The reason is a revision has been made by the national OCA stating bylaws were written in liturgical language vs legalese. Dimitri and Don will modify our bylaws into legal terms. A review of that modification will be presented in May at our Semi-Annual meeting for parish review.

## 5) OTHER NEW BUSINESS:

Barbara Freimann asked if the Parish Council has looked into a security system in light of our recent break-in. Father explained that we are looking into various systems. A committee will investigate the various systems available to determine the best system for our needs. Larissa asked if we have pictures or a video of our assets. We do have a video produced by Renee Jones of all our assets.

Matthew Prentice asked if we had a solution to the abandon vehicle in our parking lot. Our legal team will be consulted.

Regarding emails, Deacon Matthew explained that Sharon Spaulding is working on a solution to the problem of our Friends list. Everything should be operational in the near future.

David Jefferson questioned Skip Mersereau about the status of the new liturgy books. Skip indicated a draft has been completed and it is being proofed.

Michael Thompson stated the 2016 pledge packets will be available next Sunday, November 29th.

Another question was regarding the "missing pews". They are being repaired and should soon be ready to be installed.
VIII. ADJOURNMENT \& CLOSING PRAYER:

Shirley Dean moved to adjourn the meeting, seconded by Tammy Jacobsen. Motion carried.
